From the President

Greetings,

This is the time of year when the Division president usually tells the members how great the Division's annual meetings are. I have a confession to make. I am not a cheerleader. I'm not optimistic on demand. I tend to get weary when the exhortations come, and I have a low gag reflex. So I'm not going to tell you that the upcoming Pacific Division meeting will be one of the best and if you miss it will be to your eternal regret.

I do however, think it is an opportune time to reflect on why one goes to meetings at all. What purpose does the Divisional meeting serve? In short, why bother?

I would argue that much that is done throughout the field of plant pathology is not revolutionary or earth moving. Some of the work is silly, some I consider wrongheaded, and precious little is truly provocative. However, that is not to say that the field lacks work that is relevant, interesting, and exciting. Most of the work being done chips away at the mountain of the unknown – little pieces are taken off and fit into a larger mosaic of understanding. Hopefully much of it will eventually prove useful in managing plant diseases, or in somehow diminishing their impact.



The charge for self-parking is \$8.00 per day (with in and out privileges) or \$12.00 per day for valet parking.

How to get there:

San Jose has its own international airport, which is 4 miles from the Hilton. There is *no complimentary shuttle service from the hotel*, but a taxi ride will cost only about \$10.00 - \$15.00. Alternately, catch the free VTA SJC Airport Flyer (#10 shuttle) in front of the baggage claim area to connect with VTA Light Rail @ the Metro/Airport Station. Catch a south-bound train to the Convention Center Station, cost \$1.25.

Visitors may fly into the San Francisco airport, which is 35 miles from the Hotel, about 45

minutes drive time. A taxi or limo from the San Francisco airport will cost between \$70.00 - \$75.00.

What's there:

EARLY CAREER AWARD

CALL FOR NOMINATIONS

All application materials must be received by March 29, 2002

This award was established in 1999 to honor selected individuals belonging to the Pacific Division with 10 or fewer years of postgraduate experience and/or service. The award can be for a single outstanding contribution or for sustained significant notable contributions to plant pathology in extension, research, teaching or industry.

Any member or group of members belonging to the Pacific Division may make nominations.

The Early Career Award is to be awarded as appropriate only in years when exceptional candidates are nominated. No more than one award will be given each year. Nominations will be held over for three years and can be updated by the nominating member(s) as appropriate.

To nominate a candidate:

Prepare a nomination statement (no more than two pages double-spaced) giving the name, year and name of institution granting degrees, current position and affiliation of the nominee. Include a description of the accomplishments and any supporting citations or other material that qualify the nominee for the award.

Prepare an accurate biographical sketch of the nominee not exceeding 1,000 words.

Nomination deadline: March 29, 2002

APS Pacific Division Lifetime Achievement Award

Nominations are invited for the Pacific Division Lifetime Achievement Award. This award is given to senior members of the Pacific Division of the American Phytopathological Society (APS) in recognition of distinguished contributions to plant pathology and service to the Pacific Division. Any current member of the Pacific Division and the APS who has made outstanding contributions throughout his or her career to the science of plant pathology is eligible for nomination. The contributions may have been in research, teaching, extension, or any other aspect of plant pathology in either an academic or non-academic environment.

To nominate a candidate:

Prepare a nomination statement (no longer than 2 pages double-spaced) giving the name, position, and affiliation of the nominee and a critique that includes the nature, scope, and relevance of the contributions that qualify the nominee for consideration. *Contributions specific to service to the Pacific Division should especially be included.*

Prepare an accurate biographical sketch of the nominee not exceeding 1,000 words.

Graduate Student Paper Competition Awards

Graduate students are encouraged to enter a paper into the student competition. Competition winners receive a cash award: \$200.00 for 1st place, \$150.00 for 2rd, and \$100.00 for 3rd, plus a plaque commemorating their accomplishment.

Students must be:

Enrolled as a regular student in an accredited graduate school in the Pacific Division, Must be a member of the Pacific Division (it is not too late to become a member!), Be sole or senior author of the paper, and make the oral presentation.

Students may enter only one paper in the competition, and it must deal with research in plant pathology. Papers are judged on content (manner in which the data was obtained), originality of the research, and presentation of the results.

Last year nearly all entrants in the competition were from the University of California, and it is time to broaden the scope of the competition.

Students who are interested in entering the competition need only check the appropriate box on the Pacific Division abstract form (http://www.apsnet.org/meetings/div/instruct.asp) and make sure you are a member of the Pacific Division.

Students in need of monetary assistance for travel to the meeting should apply for a student travel grant. The Pacific Division has available up to five student travel grants of \$200.00 each. Students who win travel grants from the Pacific Division will automatically be entered in the competition.

So give it a whirl – as they say, you can't win if you don't enter!

STUDENT TRAVEL AWARD

CALL FOR APPLICATIONS

Application deadline April 22, 2002

APPLICATION PROCEDURE:

All application materials must be received by April 22, 2002

Applications are invited for the Pacific Division STUDENT TRAVEL AWARD. This award, established in 2000, is intended to increase opportunities for students attending institutions within the Pacific Division region to participate in APS Pacific Division meetings. Awards of \$200 will be available to APS/APS Pacific Division student members giving oral presentations at the Division meeting. Students who receive an award will not be eligible to apply for an award the following year. Preference will be given to students who have never received a Division travel award. Students who receive a travel award will automatically be entered in the graduate student paper competition.

Application packets must include the following:

- 1. Abstract as submitted for the Division meeting.
- 2. One page letter that includes the following:
 - a. Description of past attendance and participation in any APS meetings (i.e., presentations, committee activities, etc.). Indicate if you ever received a Pacific Division Student Travel Award. If you have received an award, indicate year in which the award was granted.
 - b. Briefly (one paragraph each) describe how attendance at the Division meeting would benefit you and suggest one way to increase the involvement of students in Division meetings.
- 3. Supporting letter (one page maximum) from your major professor. This letter can include
 - a. Reason student is attending the meeting.
 - b. Scientific, academic and creative merits of the student.
 - c. Any special circumstances that make attendance at the meeting dependent on receiving a Student Travel Award.
