Ninety-sixth Annual Report of the American Phytopathological Society

Annual Meeting

The 96th Annual Meeting of the American Phytopathological Society was held at the Anaheim Convention Center in Anaheim, California, July 31- August 4, 2004. Over 1,500 plant pathologists from more than 32 countries attended the meeting. **President Gary Bergstrom** welcomed participants to the APS plenary session "Networks for Plant Health."

Plenary speakers included **Kenneth Frazier**, Director, University of Wisconsin Library System, **George W. Korch** Chief of Medical, Chemical and Biological Defense Research Program, Defense Threat Reduction Agency, U.S. Department of Defense, **Robert S. Zeigler**, Director Generation Challenge Program, CIMMYT, Mexico, and **Richard E. Falloon**, New Zealand Institute for Crop & Food Research. Plenary talks covered the new partnerships between the libraries and scientific society publishers, the integration of plant biosecurity into the U.S. biodefense network, building genetic resource networks for plant protection in developing countries, and the networks of plant health societies from a regional (Australasian) and global (ISPP) perspectives. Membership

APS membership as of June 30, 2004 was 4,933, which was an increase of 127 over 2003.

- The percent of membership residing outside the United States remained constant at 31% for the eighth consecutive year, with 13% of the international members being from Canada.
- Student and post doc membership each increased by 0.5%. Together these represent 17.5% of membership.

• No change from 2003


Emeritus/life members - 601,

Report of the Business Meeting

The Eleventh Annual Networking Breakfast and 96th APS Business Meeting were held on August 3, 2004 in the Anaheim Convention Center, Anaheim, CA. Following breakfast, President **G. Bergstrom** called the business meeting to order and welcomed attendees. Winners of student travel awards and International Travel Award were recognized. Pres. Bergstrom extended appreciation to the over 500 members who volunteered in APS over the past year. Secretary **C. Ishimaru** reported on the membership of the Society and gave the Necrology Report. Treasurer **E. Stromberg** gave the APS Financial Status Report. Pres. Bergstrom recapped some of the highlights of APS activities since the last meeting.

APS President **G. Bergstrom transferred** the gavel to **J. MacDonald.** Pres. **MacDonald** gave closing remarks and invited everyone to the 2005 APS Annual Meeting in Austin, TX, July 30 – August 3, 2005, the theme of which will be **Looking to the Future.**

Report of Council Meetings

Midyear. President **G. Bergstrom** presided at the 2004 Midyear Council Meeting held at APS headquarters on February 20-22, 2004. *See May 2004 issue of Phytopathology News for meeting summary*.

Annual. President **G. Bergstrom** presided at the 2004 Annual Council Meeting in Anaheim, CA, Saturday, July 31, 2004 and Wednesday, August 3, 2004. Persons completing terms on Council are listed in the Report of the Business Meeting.

Council continued using a knowledge-based governance system in which it functions as a committee of the whole during most of its meetings. With this format, reports are strategically driven and recommendations generated through standing committees, offices, boards and ad hoc committees.

Brief committee and implementation updates

Scientific Programs Board (SPB) sought to streamline efficiencies in the planning of the annual meeting by requesting changes in the Manual of Operation (MoO) to eliminate the Annual Meeting Program Committee and to transfer responsibilities to the Planning Committee.

Publications Board informed council that web-based journal submission (manuscript tracking) is in process. The possibility of quarterly submission of articles for F&N and B&C are being reviewed. APS Press wishes to retain copyrights on visual materials, with no change in policy at this time.

Ad Hoc Journal Operations Committee updated council on the current digitization of back issues in conjunction with University of Wisconsin Library System. Implementation of open-access for back issues post 1997 is still being determined. Staff is proactively signing institutional members to online site licenses.

Ad Hoc Early Career Professionals Committee requested to be instituted as a standing General Policies Committee. They are currently developing a benchmarking tool to assist members in planning their career. Advice from senior career professionals will be sought.

Ad Hoc Awards and Honors Issues Committee reviewed the current APS sponsored Awards and Honors, the process and committees and made several recommendations to enhance the process. Electronic submissions, earlier submission date, inclusion of non-Fellows on the committee, Fellows as candidates for Excellence Awards, establishment of a new service award, "Volunteer of APS", were proposals submitted to council.

Ad Hoc Centennial Committee proposed a structure of five subcommittees, Products, Finance, Display, Presentation, and Program, each with a chair from the base committee. They will be asked to prepare listings of items under their purview. The Centennial committee is in discussion with various committees for historical sessions leading up to the 2008 meeting.

- 7. From ad hoc Awards and Honors Committee the following motions passed: : that the committee composition should allow for APS members who receive non-Fellow awards, that Fellows be eligible to receive awards of excellence based on their contributions following their Fellow award.
- 8. From Publication Board: to approve recommendation of new PHP Editor-in-Chief, Mike Benson, the appointment of Daniel Egel for the position of Editor-in-Chief of Fungicide and Nematicide Tests, the appointment of MPMI senior editors; two for Pathogen and Plant Virus Interactions sections, S. P.Dinesh-Kumar and Peter Dodds, and for Plant-Insect Interactions, Linda Walling.
- 9. From Committee (OEC) to approve Darin Eastburn as the next director of OEC 2005-2008 and the addition of the APSnet feature editor as a member of OEC.
- 10. From Committee (SPB) to increase annual allocation of symposium budget. Council approved a \$5K increase for invited nonmembers to the annual meeting. SPB also proposed that the Program Committee be dissolved and its responsibilities be subsumed by the Planning Committee, which will seek and receive input from the chairs of the subject matter and general policy committees. Motion was approved.
- 11. From Committee (FAC) to appropriate \$25K for three months into the Operating Reserve Fund.
- 12. From ad hoc Early Career Professionals Committee a motion was received an approved for the creation of an early career professional standing committee.
